## **INTERNSHIPS AT HOLY CROSS**

Internships are an essential part of an undergraduate's preparation for fruitful careers. Whether students plan on commencing a career immediately after graduation, or they seek to pursue graduate or professional studies, internships are a requisite experience. Because many internships are unpaid, these essential opportunities can be beyond reach for many at Holy Cross. Support of internships through the College's Center for Career Development

ensures that the formation for career and professional success is open to all of our students, and that they are empowered to complement the study of the liberal arts with invaluable practical experience.

Due to the consequences of the COVID-19 pandemic, many in-person internships were canceled this year, but thanks to the generosity of alumni, parents and friends, many remote opportunities were created, enabling students to participate in formative placements.

To accommodate the conditions of this unusual year, the typical 8-10 week, 35 hour/ week minimum was waived in some cases to allow for projectbased micro internships and shorter remote internships. All internship placements required:

- A dedicated supervisor who oversaw the learning and growth of the student
- Weekly (at a minimum) meetings with the supervisor
- Mutually agreed upon Learning Outcomes and goals for the internship

- Proper on-boarding and training
- A platform for communication and flow of work (Zoom, Skype, Google Meets, etc.) free of charge
- ▶ Participation in staff meetings
- A final written evaluation of the student's performance completed by the employer at the end of the internship for the College's Center for Career Development
- ▶ Student support by professional staff in the College's Center for Career Development
