What is the overall <u>deductible</u> ?	Medical & Prescription Drug Deductible: \$2,000 member/ \$4,000 family Benefits are administered on a Plan Year basis.	Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u> ?	Yes: <u>preventive care</u> , routine eye exams, are covered before you meet your <u>deductibles</u> .
